For valuable consideration, the receipt and sufficiency of which is hereby acknowledged, I hereby agree to the following:

- 1. I understand that the child/ward referred to in this agreement is a person below the age of majority, which is 18 years.
- 2. I hereby agree and consent to the Department of Education, Innovation and Gender Relations ("**DOEIGR"**) and/or DOEIGR's agents photographing my child/ward or otherwise reproducing my child's/ward's likeness in a manner and form to be determined at DOEIGR's sole discretion. I warrant and represent that my child/ward has not at any time suffered any illness, disorder or injury, and is not presently receiving treatment for any illness, disorder or injury, which would or potentially would render it unsafe for my child/ward to participate in photographing, filming, taping, recording or any other reproduction.
- 3. On behalf of my child/ward, I hereby irrevocably and unconditionally grant to DOEIGR and its related and affiliated agencies ("**DOEIGR sub departments**"), in perpetuity and throughout the world, the right to:-
 - 3.1 copy, store, publish, sell, distribute, communicate to the public, transmit, perform, use and otherwise exploit such photographs of my child's/ward's likeness ("Materials") for any of their commercial or non-commercial purposes, in full or in part, in all media whether now known or hereinafter conceived without limitation to (i) printed, digital and/or online publications and (ii) promotional and/or advertising materials, in any form and manner whatsoever, in connection with any other works of any type; and
 - 3.2 edit, adapt, add to and transform the Materials.
- 4. I understand that DOEIGR shall be the sole and exclusive owner of the Materials and on behalf of my child/ward, I hereby assign absolutely with full title guarantee all of such right, title and interest in and to the Materials to DOEIGR to which I am and/or my child/ward is now, or at any time after the date of this Agreement may be, entitled by virtue of the laws in force in Saint Lucia and in any other part of the world, including without limitation all intellectual property rights, throughout the world for the whole term.
- 5. On behalf of my child/ward, I hereby irrevocably waive all moral rights to which I may be entitled under The Copyrights Act CAP 13.07 (Saint Lucia) in favour of the DOEIGR, as amended from time to time.*
- 6. I acknowledge and agree that DOEIGR shall not be under any obligation to use or exploit the Materials and I waive any right that I may otherwise have to inspect or approve a finished product or copy embodying the Materials.

- 7. On behalf of my child/ward, I hereby irrevocably waive all remuneration payable to my child/ward in connection with the Materials or by reason of the production, distribution and/or exploitation of any Materials pursuant to this Agreement.
- 8. I agree that the DOEIGR may use my child's/ward's name, any biographical and other information provided by me for promotional and advertising purposes.
- 9. I represent and warrant that I have the full power and authority to enter into this Agreement on behalf of my child/ward for the above stated purpose; that the grant and other permissions under this Agreement are not in conflict with and do not violate any commitment, agreement or understanding that I or my child/ward now have or will have with any other person or entity; that the exercise by the DOEIGR of the rights granted under this Agreement will not violate the rights of any person or entity and will not cause the DOEIGR to incur any liability to any person or entity.
- 10. Without prejudice to any other rights and consent granted pursuant to this Agreement, I consent to the DOEIGR on behalf of my child/ward to:-
 - 10.1 storing copies of the Materials and my child's/ward's contact details on any database for the purposes of this Agreement;
 - 10.2 disclosing the Materials and my child's/ward's contact details to any agents or third party service providers for the purpose of carrying out technical, logistical or other functions on behalf of DOEIGR, related and affiliated companies; and
 - 10.3 transferring and processing the Materials and my child's/ward's contact details globally with members of the DOEIGR and their respective agents or third party service providers for the aforesaid purposes.

The DOEIGR Group shall be entitled to assign the rights and authorisations hereby assigned to it in whole or in part to third parties or to grant sub-licenses to such third parties.

This Agreement shall be interpreted in all respects in accordance with the Laws of Saint Lucia and shall be subject to the exclusive jurisdiction of the Saint Lucian courts.
